



Official Rules for the New Jersey Lottery VIP Club Opt-In Drawings (“Official Rules”):

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Winners of the New Jersey Lottery VIP Club Opt-In Drawings (collectively “Opt-In Drawings” and each an “Opt-In Drawing”) will be selected by a random computerized drawing of all entries submitted in compliance with these Official Rules. As set forth in the Finalist Selection and Verification requirements of these Official Rules, to claim a Prize, each randomly selected winner shall be required to provide such information and documentation as may be required by the New Jersey Lottery or its designee, in order to verify his/her compliance with the requirements of these Official Rules. As a condition of entering an Opt-In Drawing, entrants agree to be subject to and comply fully with these Official Rules, and entrants hereby agree to be bound by the Image Authorization and Waiver and Release of Liability.

Eligibility: Must be at least 18 years of age and a member of the New Jersey Lottery VIP Club at least 72 hours prior to entry into a particular Opt-In Drawing and to claim a Prize. Open only to legal residents of the United States of America and the District of Columbia. Individuals can register for the New Jersey Lottery VIP Club for free via the New Jersey Lottery’s website (NJLottery.com). Employees and their immediate families living in the same household of the New Jersey Lottery, Northstar New Jersey Lottery Group, LLC, IGT Global Solutions Corporation, Scientific Games International, Inc., their direct vendors and their advertising agencies, are not eligible to participate in the Opt-In Drawings.

Entry Methods: There are two (2) ways for VIP Club members (sometimes referred to throughout these Official Rules as “entrant” or “you” or “your”) to enter Opt-In Drawings. VIP Club members who have chosen to receive Sweepstakes and Opt-In Drawings notifications through Opt-In Email and/or Opt-In Text notifications from the New Jersey Lottery will receive an Opt-In Email and/or Opt-In Text when an Opt-In Drawing is available. The VIP Club member must open the Opt-In Email or Opt-In Text, click the link provided in the particular Opt-In Email or Opt-In Text, and follow the instructions in the Opt-In Email or Opt-In Text prior to the announced end of the Opt-In Drawing entry period specified in the particular Opt-In Email or Opt-In Text. **Regardless of entry method – Opt-In Email or Opt-In Text - each VIP Club member may only submit one (1) entry into each Opt-In Drawing.** A VIP Club member will receive an on-screen confirmation of his or her entry into a particular Opt-In Drawing after submission.

Where more than one (1) Opt-In Drawing opportunity is being offered at a time, the New Jersey Lottery VIP Club member must enter each separate Opt-In Drawing, within the time periods specified and in accordance with the instructions specified in the Opt-In Email or Opt-In Text, in order to be eligible to win a Prize for the particular Opt-In Drawing. Opt-in Drawings will be scheduled at the discretion of the New Jersey Lottery or its designee. The New Jersey Lottery or its designee reserves the right, in its/their sole discretion, to cancel, terminate, modify, reschedule or suspend any Opt-In Drawing without prior notice.

Any entry deemed by the New Jersey Lottery or its designee to be: (a) obscene, offensive, or otherwise inappropriate; (b) a violation of any law, regulation or rule, including these Official Rules and/or the Lottery's Social Media Community Guidelines; or (c) unfair, uncooperative, disruptive, fraudulent, potentially fraudulent, or unusual behavior or activity, may be disqualified without notice at the sole discretion of the New Jersey Lottery or its designee. All decisions with regard to any Opt-In Drawing, including these Official Rules, made by the New Jersey Lottery or its designee, shall be final. No purchase necessary to enter or win. A purchase will not increase your chances of winning. The Opt-In Drawings shall be void where prohibited or restricted by law. The Opt-In Drawings are subject to all applicable federal, state and local laws and regulations.

Prizes: Randomly selected and verified winners of each Opt-In Drawing will each receive the Prize specified for the particular Opt-In Drawing in the Opt-In Email and/or the Opt-In Text for the particular Opt-In Drawing. The New Jersey Lottery or its designee reserves the right to substitute the Prize without notice with an alternative prize of equal value. Winners are solely responsible for payment of all applicable federal, state and local taxes associated with any Prize awarded in connection with an Opt-In Drawing.

Image Authorization: As a condition of entering an Opt-In Drawing, the entrant hereby irrevocably consents to the use of his/her name, town and state of residence, photograph(s), video(s), voice, image and likeness (collectively "Image") by New Jersey Lottery and its agents, representatives and designees in any and all of the New Jersey Lottery's online, printed and social media advertisements, promotions, publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to the entrant. The entrant hereby irrevocably authorizes the New Jersey Lottery and its agents, representatives and designees to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by the entrant, the entrant's Image for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, the entrant hereby irrevocably waives any right to royalties or other compensation arising from or related to the use of the entrant's Image. The entrant hereby holds harmless and forever releases, discharges and indemnifies the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC, from any and all liability, injury, damage, death, litigation, claim, cause of action, loss or demand, known or unknown, which the entrant, the entrant's heirs, agents, representatives, executors, administrators, or any other persons acting on the entrant's behalf or on behalf of the entrant's estate have or may have by reason of this Image Authorization, including without limitation, all claims for invasion of privacy, right of publicity, defamation, false endorsement, and any other claims regarding personal and/or property rights. The New Jersey Lottery Law (N.J.S.A. 5:9-1 et seq. and N.J.A.C. 17:20-1.1 et seq.) allows the holders of winning New Jersey Lottery tickets or shares to choose to remain anonymous. This does not apply to the Opt-In Drawings.



Waiver and Release of Liability: As a condition of entering an Opt-In Drawing, the entrant agrees to forever waive, discharge, indemnify and release the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective agents, owners, operators, commissioners, officers, directors, elected officials, members, shareholders, contractors, subcontractors, employees, partners, and designees, and each of their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC (collectively “Affiliates”), from any and all liability, injury, damage, death, litigation, claim, cause of action or loss that may occur, directly or indirectly, whether known or unknown, and whether caused by negligence or not, arising out of or associated with the entrant’s participation in the Opt-In Drawing, the entrant’s acceptance, possession, use or misuse of any Prize awarded in connection with the Opt-In Drawing, any defect with the Opt-In Drawing, and/or any error in the administration or operation of the Opt-In Drawing. The entrant, on behalf of him/her self, his/her spouse, heirs, executors, administrators, representatives, successors, assigns and next of kin, waive all claims for damages, injuries and/or death, whether known or unknown, and whether caused by negligence or not, sustained to the entrant or the entrant’s property that the entrant may have against the New Jersey Lottery and Northstar New Jersey Lottery Group, LLC, and its/their respective Affiliates, arising out of or associated with the entrant’s participation in the Opt-In Drawing, the entrant’s acceptance, possession, use or misuse of any Prize awarded in connection with the Opt-In Drawing, any defect with the Opt-In Drawing, and/or any error in the administration or operation of the Opt-In Drawing. As a condition of entering an Opt-In Drawing, entrant agrees that all disputes, litigation, claims, controversies, or causes of action arising out of or relating to the Opt-In Drawing or any Prize awarded shall be resolved individually, without resort to any form of class action.

Finalist Selection and Verification: Each randomly selected finalist and alternate finalist shall be subject to verification by the New Jersey Lottery or its designee as set forth in these Official Rules. A VIP Club member who attempts to enter a particular Opt-In Drawing after the announced end of the Opt-In Drawing entry period will be disqualified from that particular Opt-In Drawing. Finalists and alternate finalists of each Opt-In Drawing will be selected by a random computerized drawing of all entries submitted in compliance with these Official Rules. The number of finalists selected for a particular Opt-In Drawing will be specified in the Opt-In Email and/or Opt-In Text issued in connection with the particular Opt-In Drawing. For every one (1) potential winner randomly selected for an Opt-In Drawing, five (5) alternate potential winners will also be randomly selected for that Opt-In Drawing.

Finalists will be notified by email by the New Jersey Lottery or its designee through the email address on file with the VIP Club, and if necessary, confirmed by telephone at the number on file with the VIP Club, and provided with instructions on how to claim their Prize, which instructions shall include, among other things, providing such information and documentation as may be required by the New Jersey Lottery or its designee within the time provided by the New Jersey Lottery or its designee. The failure of any finalist to fully comply with all such instructions shall result in the disqualification of that finalist from the particular Opt-In Drawing and forfeiture of his/her Prize. In the event of such disqualification, an alternate finalist will be notified in order of his/her selection for the particular Opt-In Drawing, by email through the email address on file with the VIP Club, and if necessary, confirmed by telephone at the number on file with the VIP Club, with instructions on the time and manner in which to claim his/her Prize, which instructions shall include, among other things, providing such information and documentation as may be



required by the New Jersey Lottery or its designee within the timeframe required by the New Jersey Lottery or its designee. As a condition of entering an Opt-In Drawing, entrants agree that if they are selected as a finalist or alternate finalist, they shall provide complete, accurate and truthful information to the New Jersey Lottery or its designee.

The Prize will be sent by the New Jersey Lottery or its designee to each verified winner in full compliance with these Official Rules by UPS to the address on file with the VIP Club. VIP Club members are solely responsible for ensuring that their VIP Club registration information, including home address and telephone number, are correct and up to date. The New Jersey Lottery and Northstar New Jersey Lottery Group, LLC shall not be liable for lost, undelivered or incorrectly addressed packages. Cash will NOT be awarded in lieu of Prize. The New Jersey Lottery and Northstar New Jersey Lottery Group, LLC shall not have any liability for an entrant's failure to receive a finalist or alternate finalist selection notification for any reason, including but not limited to the entrant's spam, junk email or other security settings or for an entrant's provision of incorrect or otherwise non-functioning VIP Club registration information. As a condition of entering an Opt-In Drawing, entrant agrees that the New Jersey Lottery and its agents, representatives and designees may, and entrant gives permission to the New Jersey Lottery and its agents, representatives and designees to, publish entrant's full name, town and State of residence, and Prize across the New Jersey Lottery's social media platforms and Website if entrant is a verified winner of an Opt-In Drawing.

Changes: Official Rules may be changed at any time and without prior notice in the sole discretion of the New Jersey Lottery or its designee.

Disputes: The Opt-In Drawings are governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.

Opt-In Drawings Integrity: The New Jersey Lottery or its designee reserves the right to cancel, terminate, modify, reschedule or suspend any Opt-In Drawing for any reason, including but not limited to if it/they determine(s), in its/their sole discretion, that a virus, bug, unauthorized human intervention, fraud or other cause (the "Event") has or is corrupting or affecting the administration, security, fairness or proper conduct of an Opt-In Drawing. In such a case, the New Jersey Lottery or its designee, in its/their sole discretion, may select winners from all eligible entries received prior to or after resolution of (if appropriate) the Event. The New Jersey Lottery or its designee reserves the right, in its/their sole discretion, to disqualify any individual who tampers with or attempts to tamper with the entry process for an Opt-In Drawing, the operation of an Opt-In Drawing or otherwise violates these Official Rules. The New Jersey Lottery or its designee has the right, in its/their sole discretion, to maintain the integrity of all Opt-In Drawings and to void an entry for any reason, including the use of bots, macros or scripts or other technical means for entering.

Any attempt by an entrant to deliberately damage any system or program of the New Jersey Lottery and/or its agents, representatives or designees, or to undermine the legitimate operation of any Opt-In Drawing in any way, may be a violation of criminal and civil laws. If such an attempt is made, the New



Jersey Lottery and/or its agents, representatives or designees reserve the right to seek compensation from any such person to the fullest extent permitted by law.

Severability; Waiver; Headings: The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The headings used in these Official Rules are for convenience only and shall not affect the interpretation of any of the provisions of these Official Rules. The failure to enforce any provision of these Official Rules will not constitute a waiver of that or any other provision of these Official Rules.

Privacy Policy: Participation in the Opt-In Drawings is subject to the Privacy Policy stated on the New Jersey Lottery website. To read the Privacy Policy visit NJLottery.com.
